## REGULAR MEETING OF THE BIG STONE COUNTY BOARD November 20, 2018

The Big Stone County Board of Commissioners met in the Commissioners' Room at 8:30 AM on Tuesday, November 20, 2018. Chairman Olson called the meeting to order with Commissioners Athey, Backer, Berning and Sandberg present. Also present were Dillon Dwyer of the Ortonville Independent, Erick Klepel, IT Director Terry Ocaña, Family Services Director Pam Rud, Deputy Auditor Heather Henrich, County Attorney Joe Glasrud and County Auditor Michelle Knutson. The Pledge of Allegiance followed.

Motion by Berning, seconded by Backer and carried to approve the minutes of the November 6<sup>th</sup> regular meeting.

Motion by Backer, seconded by Sandberg and carried to approve the agenda with noted addition.

Attorney Glasrud recommended that the Board proceed with contracts with the cities of Beardsley, Graceville and Ortonville for his office's services.
