GENERAL REQUIREMENTS FOR MOVING PERMIT

1. Minimum 48 hours notice for single trip permits to be approved.
2. All oversize and overweight movements shall be during daylight hours only unless clearly noted on permit.
3. Spring time load restrictions over rule permit and must be adhered too.
4. No movement shall be made when roads are soft or during periods of poor visibility.
5. Permission for movement over roads other than County Highways must be obtained from authorities under whose jurisdiction such roads come.
7. Applicant shall coordinate with all utility companies for overhead wires, cables, etc., along route. Big Stone County issues the permit but does not guarantee clearances needed for your load. You must inspect the route and make necessary arrangements before you move.
8. The applicant shall comply with all rules posted on any bridges or underpasses over or under which shall be traveled and assume all risks thereto. No signs, guardrails or other county or private property shall be moved unless written authority is given.
9. Movement within incorporated areas shall be coordinated with local law enforcement and/or other authorized local representatives.
10. All Federal law, Minnesota Statutes and Rules must be complied with, including, but not limited to, vehicle registration laws, pilot car requirements and utilization of all necessary signing, flagging, and lighting of load and towing unit.
